THE CONDITION OF THE ABOVE BOND is that the said principal is now or is about to become a service contract provider in  
 accordance with the provision of Sections 385.300, 385.302, 385.304, 385.306, 385.308, 385.310, 385.312, 385.314, 385.316, 385.318,  
 and 385.320, RSMo. This bond shall continue in force until cancelled as provided for herein.

If the said principal shall fully comply with the provisions of the Laws of the State of Missouri, and shall have been reported to the  
 Director of Commerce and Insurance, before February 1 of each calendar year, on the form and in the manner required by the Director  
 of Commerce and Insurance for service contract providers, and shall do and perform all other things required by Sections 385.300,  
 385.302, 385.304, 385.306, 385.308, 385.310, 385.312, 385.314, 385.316, 385.318, and 385.320, RSMo, including but not limited to  
 said principal's faithful performance of its obligations to its service contract holders, then this bond shall be of no effect; otherwise to be  
 and remain in full force and effect.

The surety on the bond shall have the right to cancel the bond upon giving thirty (30) days notice to the Director of the Missouri  
 Department of Commerce and Insurance. The surety thereafter shall be relieved of liability for any breach of condition occurring after the  
 effective date of the cancellation.
