VOLUNTARY FORFEITURE

It is hereby agreed by CONTINENTAL TITLE HOLDING COMPANY DBA CONTINENTAL TITLE COMPANY Producer Number 8013453 (Continental) and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374, 375 and 381 RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Continental is licensed as an insurance producer by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 374, 375 and 381, RSMo ;


WHEREAS, the investigation has revealed that Continental employed Amy Plummer, not then a licensed insurance producer, as a searcher between April 2, 2012 and May 6, 2013 in violation of Sections 381.115.1 and 381.115.2 (2), RSMo (Supp 2012), a ground to discipline Continental's insurance license pursuant to Section 375.141.1 (2), RSMo (Supp 2012) subjecting it to enforcement action by the Director;

WHEREAS, Continental has been informed of the nature of its violation, of its right to counsel and of its right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration to discipline its producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that it understands its rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any other action or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Continental does hereby voluntarily and knowingly surrender and forfeit the sum of one thousand five hundred dollars (\$1,500.00), such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Continental shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration by cashier's check or money order made payable to the Missouri State School Fund no later than July 18, 2013.


