VOLUNTARY FORFEITURE

It is hereby agreed by Whitney S. Blocker and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374, 375, and 385 RSMo, include the supervision and regulation of the business of motor vehicle extended service contracts (hereinafter, MVESC);

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of MVESC pursuant to Sections 374.085, 374.190, and 385.216 RSMo and is authorized by the Director to recommend enforcement action under the laws relating to MVESC;

WHEREAS, Whitney S. Blocker has applied to receive a Motor Vehicle Extended Service Contract (MVESC) producer's license from the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 385, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division concerning

Whitney Blocker's falsification of an application for a MVESC license dated, April 09, 2013. Specifically, Whitney Blocker answered "No" to Background Question #1 on the application which asks, "Have you ever been convicted of a crime, had a judgement withheld or deferred, or are you currently charged with committing a crime?"

WHEREAS, information has been obtained by the Division of Consumer Affairs that Whitney S. Blocker, on August 30, 2000, pled guilty in the Superior Court of Arizona to the felony charge of "Possession of Burglary Tools." As a result of his plea, Whitney Blocker was sentenced to serve eighteen months on probation, of which six months included incarceration in the Maricopa County Jail. Upon completing probation, the classification was reduced to a misdemeanor. Failing to disclose this conviction in his application for licensure is grounds for discipline under Sections 385.209.1(3) RSMo (Supp. 2012) "**Obtained or attempted to obtain a license through material misrepresentation or fraud,**" and therefore subjects him to enforcement action by the Director;

WHEREAS, information has been obtained by the Division of Consumer Affairs that Whitney S. Blocker, on January 24, 2013, was charged in Jefferson County, MO Circuit Court with "Domestic Assault - 3<sup>rd</sup> Degree." This criminal matter is still pending before the court. Failing to disclose this current charge in his application for licensure is grounds for discipline under Section 385.209.1(3) RSMo (Supp. 2012) "**Obtained or attempted to obtain a license through material misrepresentation or fraud,**" and therefore subjects him to enforcement action by the Director;

WHEREAS, Whitney S. Blocker has been informed of the nature of his violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to seek civil or criminal penalties against Whitney S. Blocker, or to impose any other penalties provided for by statute for the above described

violations, after being afforded the opportunity to consult legal counsel, Whitney S. Blocker does hereby voluntarily and knowingly surrender and forfeit the sum of two hundred fifty dollars (\$250.00), such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo (Supp. 2012).

Whitney S. Blocker shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than **Friday, May 31, 2013**.
