**REFUSAL TO ISSUE INSURANCE PRODUCER LICENSE**

On February 28, 2006, Kathryn Turner, as senior counsel for the Investigations Section of the Division of Consumer Affairs, submitted a petition to the Director alleging cause for refusing to issue the insurance producer license of David L. Walton ("Applicant"). After reviewing the petition, and the investigative report, the Director issues the following findings of fact, conclusions of law and summary order:

**FINDINGS OF FACT**

1. David L. Walton is a Missouri resident with a residence address of 309 Vida Avenue, St. Louis Missouri 63125.
2. On December 2, 2005, David L. Walton ("Applicant") submitted a Uniform Application for Individual Insurance Producer License to the Missouri Department of Insurance.
3. Question 39-1. under Background Information asks:  

Have you ever been convicted of, or are you currently charged with, committing a crime, whether or not adjudication was withheld?
4. Applicant answered the question "Yes".

5. Applicant disclosed a conviction for the class B felony of Distribution and Delivery of Methamphetamine in the Circuit Court of Wayne County, Missouri on February 26, 1991. Applicant was sentenced to 5 years in prison.
6. This order is in the public interest.

**CONCLUSIONS OF LAW**

7. Section 375.141.1 RSMo Cum Supp 2005 provides, in part:

The director may suspend, revoke, refuse to issue or refuse to renew an insurance producer license for any one or more of the following causes:

(6) Having been convicted of a felony or crime involving moral turpitude;


8. Applicant has been convicted of the class B felony of Distribution and Delivery of Methamphetamine, a ground for refusal of a producer license under Section 375.141.1(6) RSMo Cum Supp 2005.
9. This order is in the public interest.

**ORDER**

IT IS THEREFORE ORDERED that the issuance of the insurance producer license of Applicant David L. Walton is hereby summarily REFUSED.
