It is hereby agreed by Charles Bowman and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the bail bond business;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond agents and general bail bond agents in the bail bond business pursuant to Section 374.085, RSMo and Section 374.764, RSMo (Supp. 2012) and is authorized by the director to recommend enforcement action under the laws relating to bail bonds;

WHEREAS, Charles Bowman is licensed as a bail bond agent;

WHEREAS, information has been received by the Consumer Affairs Division concerning Charles Bowman's violation and grounds for discipline exist under:

Section 374.755.1(12) RSMo (Supp. 2012) – Failing to provide a copy of the bail contract, prenumbered written receipt for acceptance of money, or other collateral for the taking of bail to the principal ...or any person providing funds or collateral for bail on the principal's behalf,

which subjects Charles Bowman to enforcement action by the Director;

WHEREAS, Charles Bowman has been informed of the nature of his violation, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration to discipline his bail bond license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the bail bond agent license of Charles Bowman or to impose any other penalties provided for by statute for the above-described violations, or after being afforded the opportunity to consult legal counsel, Charles Bowman does hereby voluntarily and knowingly surrender and forfeit the sum of \$300.00 such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Charles Bowman shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration by cashier's check or money order made payable to the Missouri State School Fund no later than Jun3 14, 2013.
