VOLUNTARY FORFEITURE

It is hereby agreed by Bart Cooper and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance; Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond agents and general bail agents in the bail bond business pursuant to Section Chapter 374.085 and 374.190, RSMo 2000 and is authorized by the director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Bart Cooper is licensed as a general bail bond agent by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 374, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division concerning Bart Cooper's violation of Section 374.755.1(5) RSMo (Supp. 2009) which subjects him to enforcement action by the Director for the following:


Misappropriation of the premium ... or a general bail bond agent for the taking of bail, incompetency, misconduct, gross negligence, fraud or misrepresentation in the performance of the functions or duties of the profession licensed; and By failing to clearly communicate the name of the properly licensed general bail bond agent.

WHEREAS, Bart Cooper has been informed of the nature of his violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his general bail bond agent license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;


NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the general bail bond agent license of Bart Cooper or to impose any other penalties provided for by statute for the above-described violation, after being afforded the opportunity to consult legal counsel, Bart Cooper, does hereby voluntarily and knowingly surrender and forfeit the sum of \$150.00 such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Bart Cooper shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than November 19, 2010.


