VOLUNTARY FORFEITURE

It is hereby agreed by M & I FINANCIAL ADVISORS, INC. and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo 2000 and is authorized by the Director to recommend enforcement action

under the laws relating to insurance;

WHEREAS, M & I FINANCIAL ADVISORS, INC. is licensed as a business entity producer by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 375, RSMo;

WHEREAS, the investigation by the Consumer Affairs Division revealed M & I FINANCIAL ADVISORS, INC. violated our insurance laws and is subject to enforcement action by the Director for the following:

Violation of Section 375.141.6 RSMo (Supp. 2010). An insurance producer shall report to the director any administrative action taken against the producer in another jurisdiction or by another governmental agency in this state within thirty days of the final disposition of the matter, which is grounds for discipline under Section 375.141.1(2) RSMo (Supp. 2010).

WHEREAS, M & I FINANCIAL ADVISORS, INC. has been informed of the nature of their violations, of their right to counsel and of their right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline their insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that they understands their rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the business entity producer license of M & I FINANCIAL ADVISORS, INC. or to impose any other penalties provided for by statute for the above-described violations, after being


afforded the opportunity to consult legal counsel, M & I FINANCIAL ADVISORS, INC., does hereby voluntarily and knowingly surrender and forfeit the sum of \$750.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

M & I FINANCIAL ADVISORS, INC. shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than May 3, 2011.
