VOLUNTARY FORFEITURE

It is hereby agreed by Erica L. Fields and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374, 375 and 384 RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Erica Fields has applied to receive a producer's license from the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 375, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division concerning Erica Fields' failure to disclose to the Department, a regulatory action against her insurance producer's license in the State of Pennsylvania. This violation constitutes grounds for discipline under Section 375.141.1(1) RSMo. (Supp. 2011) **"Intentionally providing materially incorrect, misleading, incomplete or untrue information in the license application"** and subjects her to enforcement action by the Director;


WHEREAS, Erica Fields has been informed of the nature of her violations, of her right to counsel and of her right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration to discipline her insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that she understands her rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to refuse the insurance producer license of Erica Fields or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Erica Fields does hereby voluntarily and knowingly surrender and forfeit the sum of two hundred – fifty dollars (\$250.00), such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.


Erica Fields shall submit this sum to the Department of Insurance, Financial Institutions
