VOLUNTARY FORFEITURE

It is hereby agreed by Robert Todd Haenisch and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri, (hereinafter, Director) whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Robert Todd Haenisch has a non-resident insurance producer application pending with the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 374 and 375, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division that Robert Todd Haenisch violated Section 375.141.7, RSMo (Supp. 2011) by failing to report a 2011 Felony Possession of a Controlled Substance within 30 days. This violation constitutes grounds for discipline under Section(s) 375.141.1(2), RSMo (Supp. 2011) and subjects Robert Todd Haenisch to enforcement action by the Director;


WHEREAS, Robert Todd Haenisch has been informed of the nature of the violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration to refuse his license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to refuse the license of Robert Todd Haenisch, or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Robert Todd Haenisch does hereby voluntarily and knowingly surrender and forfeit the sum of **\$500.00**, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.


