VOLUNTARY FORFEITURE

It is hereby agreed by Michael Leamanczyk and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri, (hereinafter, Director) whose duties, pursuant to Chapters 374, 375, and 384, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Michael Leamanczyk has a Missouri license as a nonresident producer and surplus lines producer with the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 374, 375, and 384, RSMo;


WHEREAS, information has been received by the Consumer Affairs Division that Michael Leamanczyk failed to file his Surplus Lines Tax Report (Appendix 3) before March 2, 2012, which is in violation of Section 384.057.1, RSMo (Supp. 2011), and Michael Leamanczyk failed to file the Surplus Lines Tax Report (Appendix 3) within fifteen days of receiving notice of such failure to file, which is in violation of Section 374.215.1, RSMo (Supp. 2011), and these matters are grounds for discipline under Sections 384.065(4) and 375.141.1(2), RSMo (Supp. 2011), subjecting Michael Leamanczyk to enforcement action by the Director;

WHEREAS, Michael Leamanczyk has been informed of the nature of the violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke the surplus lines license and producer license of Michael Leamanczyk, or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Michael Leamanczyk does hereby voluntarily and knowingly surrender and forfeit the sum of \$1,000, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Michael Leamanczyk shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than November 5, 2012.


