VOLUNTARY FORFEITURE

It is hereby agreed by Michael Crangle and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri, (hereinafter, Director) whose duties, pursuant to Chapters 374, 375, and 385, RSMo, include the supervision and regulation of the business of insurance and motor vehicle extended service contracts;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of motor vehicle extended service contracts pursuant to Chapter 385, RSMo, and is authorized by the Director to recommend enforcement action under the laws relating to motor vehicle extended service contracts;

WHEREAS, Michael Crangle has applied for his license as a motor vehicle extended service contract producer with the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Section 385.200, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division that Michael Crangle failed to correctly answer on the license application that he received a suspended sentence for the crime of possession of a controlled substance and unlawful use of drug paraphernalia, which is grounds for discipline under Section 385.209.1(3), RSMo (Supp. 2012), subjecting Michael Crangle to enforcement action by the Director;

WHEREAS, Michael Crangle has been informed of the nature of the violation, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to refuse his license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to deny the license of Michael Crangle, or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Michael Crangle does hereby voluntarily and knowingly surrender and forfeit the sum of \$250.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Michael Crangle shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than July 1, 2013.
