VOLUNTARY FORFEITURE

It is hereby agreed by Philip Twietmeyer and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374, 375 and 384 RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Philip Twietmeyer is licensed as an insurance producer and a surplus lines producer by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 375, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division concerning Philip Twietmeyer's failure to report to the Department, a regulatory action against his insurance producer's license in the State of Kentucky. **Failing to "report to the Director any administrative action taken against the producer in another jurisdiction...within thirty (30) days of the final disposition of the matter,"** is in violation of Section 375.141.6 RSMo. (Supp. 2011). This violation constitutes grounds for discipline under Section 375.141.1(1) RSMo. (Supp. 2011) **"Intentionally providing materially incorrect, misleading, incomplete or untrue information in the license application"** and Section 375.141.1(2) RSMo. (Supp. 2011) **"Violating any insurance laws, or violating any regulations, subpoena or order of the director or of another insurance commissioner in any other state"** and subject him to enforcement action by the Director;

WHEREAS, Philip Twietmeyer has been informed of the nature of his violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;


NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the insurance producer license of Philip Twietmeyer or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel,

Philip Twietmeyer does hereby voluntarily and knowingly surrender and forfeit the sum of two hundred – fifty dollars (\$250.00), such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Philip Twietmeyer shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than **Thursday, July 26, 2012**.
