VOLUNTARY FORFEITURE

It is hereby agreed by Patrick H. Webb (“Webb”) and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374 and 375 RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, on December 17, 2010 Webb applied and received a producer's license from the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 375, RSMo. In his application, Webb answered "No" to Background Question(s) #1 which asked, "Have you ever been convicted of a crime, had a judgement withheld or deferred, or are you currently charged with committing a crime?" Webb failed to disclose a January 13, 2009 guilty plea for "Theft" in Jackson County Circuit Court, State of Missouri;


WHEREAS, on December 24, 2012, Webb applied late to renew his producer's license. In that application, Webb answered "Yes" to Background Question(s) #1 which asked, "Have you ever been convicted of a crime, had a judgement withheld or deferred, or are you currently charged with committing a crime?" Only then did Webb disclose the aforementioned guilty plea, which should have been disclosed in his original application for licensure. This violation constitutes grounds for discipline under Section 375.141.1(1) RSMo. (Supp. 2012) **"Intentionally providing materially incorrect, misleading, incomplete or untrue information in the license application"** and subjects him to enforcement action by the Director;

WHEREAS, Webb has been informed of the nature of his violations, of his right to counsel, and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration to discipline his insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;


NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to refuse the insurance producer license of Patrick H. Webb or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Patrick H.

Webb does hereby voluntarily and knowingly surrender and forfeit the sum of two hundred fifty dollars (\$250.00), such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo (Supp. 2012). The penalty shall be submitted to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than **Friday, February 15, 2013**.
