VOLUNTARY FORFEITURE

It is hereby agreed by Tonya Service and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374, 375 and 385 RSMo, include the supervision and regulation of the business of motor vehicle extended service contracts;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the motor vehicle extended service contract

business pursuant to Sections 374.085 and 385.216, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to motor vehicle extended service contract business;

WHEREAS, Tonya Service has applied for a motor vehicle extended service contract producer license by the Department of Insurance, Financial Institutions and Professional Registration pursuant to Chapter 385 RSMo;

WHEREAS, information has been received by the Consumer Affairs Division that Tonya Service failed to report a delinquent tax obligation that at the time of her application was not subject to a repayment agreement on her motor vehicle extended service contract producer license application, which is grounds for discipline under Section 385.209.1 (3), RSMo (Supp. 2012);

WHEREAS, Tonya Service has been informed of the nature of her violation, of her right to counsel and of her right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to refuse her motor vehicle extended service contract producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that she understands her rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke, suspend or refuse the license of Tonya Service, or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Tonya Service, does hereby voluntarily and knowingly surrender and forfeit the sum of \$250, such sum to be paid into the Missouri State School Fund

pursuant to Sections 374.046 and 374.280, RSMo.

Tonya Service shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than March 22, 2013.
