It is hereby agreed by Anthony Poss and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, Douglas M. Ommen is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to insurance.

WHEREAS, Anthony Poss is licensed as an insurance producer by the

Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 375, RSMo;


WHEREAS, information has been received by the Consumer Affairs Division concerning Anthony Poss, which alleges that by not verifying what service area Mr. and Mrs. Closser lived in, Anthony Poss demonstrated incompetence and untrustworthiness in the conduct of business, a ground for discipline under Section 375.141.1 (8) RSMo Cum Supp 2005, subjecting him to enforcement action by the Director;

WHEREAS, Anthony Poss has been informed of the nature of his violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that s/he understands his/her rights to contest any such actions;

NOW, THEREFORE, in complete settlement of the investigation in File Number 06A000533, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the insurance producer license of Anthony Poss or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Anthony Poss, without any admission of a violation of the law, does hereby voluntarily and knowingly surrender and forfeit the sum of \$100.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Anthony Poss shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than February 19, 2007.


