It is hereby agreed by W. Dale Finke, Director of the Department of Insurance, Financial Institutions & Professional Registration and Paul Reynolds as follows:

WHEREAS, W. Dale Finke is the duly appointed Director of the Department of Insurance, Financial Institutions & Professional Registration, State of Missouri;

WHEREAS, Paul Reynolds is licensed as an insurance producer by the Department of Insurance, Financial Institutions & Professional Registration pursuant to Chapter 375, RSMo;

WHEREAS, information has been received concerning Paul Reynolds that alleges he demonstrated incompetence, dishonest practices and untrustworthiness, a ground for discipline under Section 375.141.1 (8);

WHEREAS, Paul Reynolds has been informed of the nature of said violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions & Professional Registration to REVOKE his insurance producer's license, or to recover whatever penalties may be provided for by statute and states that he understands his rights to contest any such attempt;






