### VOLUNTARY FORFEITURE

It is hereby agreed by Tasha O. Streckfuss and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, Linda Bohrer is the duly appointed Acting Director of the Department of Insurance, Financial Institutions, and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the business of bail bonds;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond applications, bail bond agents and general bail bond agents in the bail bond business pursuant to 374.085, RSMo 2000 and Section 374.764 RSMo (Cum. Supp. 2007) and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Tasha O. Streckfuss is a general bail bond agent and has applied for

a renewal of her general bail bond license;


WHEREAS, information has been received by the Consumer Affairs Division concerning Tasha O. Streckfuss's violation: Section 374.755.1 (3) RSMo (Cum. Supp. 2007) - Use of fraud, deception, misrepresentation or bribery in securing any license by the failure to disclose a 1998 and 2000 misdemeanor court action in Warren County Missouri, subjecting her to enforcement action by the Director;

WHEREAS, Tasha O. Streckfuss has been informed of the nature of her violation, of her right to counsel and of her right to contest any attempt by the Department of Insurance, Financial Institutions, and Professional Registration to refuse to renew her general bail bond license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that she understands her rights to contest any such actions;

NOW, THEREFORE, in complete settlement of the investigation in File Number 08A000692, in lieu of the institution by the Department of Insurance, Financial Institutions, and Professional Registration of any action to deny the application of a general bail bond license of Tasha O. Streckfuss or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Tasha O. Streckfuss, does hereby voluntarily and knowingly surrender and forfeit the sum of \$100.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Tasha O. Streckfuss shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than October 9, 2008.
