ORDER REFUSING TO ISSUE MOTOR VEHICLE EXTENDED SERVICE CONTRACT PRODUCER LICENSE

On February 7, 2018, the Consumer Affairs Division submitted a Petition to the Director alleging cause to refuse the motor vehicle extended service contract producer license application of Richard Jason Breadner. After reviewing the Petition, Investigative Report, and the entirety of the file, the Director issues the following findings of fact, conclusions of law, and order:

FINDINGS OF FACT

- 1. Richard Jason Breadner ("Breadner") is a Missouri resident with a residential address of 520 Harmony Lane, O'Fallon, Missouri 63366-2730.
- 2. On September 28, 2017, the Department of Insurance, Financial Institutions and Professional Registration ("Department") received Breadner's Application for Motor Vehicle Extended Service Contract Producer License ("Application").
- 3. Breadner answered "Yes" to Background Information Question 1 of the Application which asked, in relevant part: "Have you ever been convicted of a crime, had a judgment withheld or deferred, received a suspended imposition of sentence ('SIS') or suspended execution of sentence ('SES'), or are you currently charged with committing a crime?"
- 4. As further instructed by the Application, Breadner included court documents disclosing the following prosecutions:
 - a. On June 1, 2007, Breadner pleaded guilty to, and was convicted upon, each of three counts of Driving While Intoxicated Persistent Offender, a Class D Felony in violation of § 577.010.¹ The court sentenced Breadner to four years' incarceration on each count, to be served consecutively, but suspended execution of the sentences and instead ordered Breadner to complete five

years' probation. On April 16, 2010, the court revoked Breadner's probation and ordered the sentences executed. *State v. Richard J. Breadner*, St. Charles Co. Cir. Ct., Case No. 0711-CR01622-01 ("*Breadner I*").

- b. On February 25, 2011, Breadner was convicted, after his earlier guilty plea, of Driving While Intoxicated - Chronic Offender, a Class B Felony in violation of § 577.010. The court sentenced Breadner to ten years' incarceration, to be served concurrently with his sentences in *Breadner I* and *Breadner III. State v. Richard J. Breadner*, St. Louis Co. Cir. Ct., Case No. 10SL-CR03902-01 ("*Breadner II*").
- c. Also on February 25, 2011, Breadner was convicted of a separate charge of Driving While Intoxicated - Chronic Offender, a Class B Felony in violation of § 577.010. The court sentenced Breadner to ten years' incarceration, to be served concurrently with his sentences in *Breadner I* and *Breadner II. State v. Richard J. Breadner*, St. Louis Co. Cir. Ct., Case No. 10SL-CR04807-01 ("*Breadner IIP*").

CONCLUSIONS OF LAW

5. Section 385.209.1, RSMo² provides, in relevant part:

The director may suspend, revoke, refuse to issue, or refuse to renew a registration or license under sections 385.200 to 385.220 for any of the following causes, if the applicant or licensee or the applicant's or licensee's subsidiaries or affiliated entities acting on behalf of the applicant or licensee in connection with the applicant's or licensee's motor vehicle extended service contract program has:

* * *

- (5) Been convicted of any felony[.]
- 6. The Director may refuse to issue a motor vehicle extended service contract ("MVESC") producer license to Breadner pursuant to § 385.209.1(5) because he has been convicted of five felonies, specifically:
 - a. Driving While Intoxicated Persistent Offender, Breadner I;
 - b. Driving While Intoxicated Persistent Offender, id.;
 - c. Driving While Intoxicated Persistent Offender, id.;
 - d. Driving While Intoxicated Chronic Offender, Breadner II; and

- e. Driving While Intoxicated Chronic Offender, Breadner III.
- 7. Each of Breadner's felony convictions is a separate and sufficient ground for refusal pursuant to § 385.209.1(5).
- 8. The Director has considered Breadner's history and all of the circumstances surrounding Breadner's Application. Issuing Breadner a MVESC producer license would not be in the interest of the public. Accordingly, the Director exercises her discretion to refuse to issue Breadner a MVESC producer license.
- 9. This Order is in the public interest.

<u>ORDER</u>

IT IS THEREFORE ORDERED that the motor vehicle extended service contract producer license application of Richard Jason Breadner is hereby REFUSED.
