### VOLUNTARY FORFEITURE AGREEMENT

MO. DEPT. OF INSURANCE,  
FINANCIAL INSTITUTIONS &  
PROFESSIONAL REGISTRATION

It is hereby agreed by Thomas A. Aubry ("Aubry") and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, "Director" of the "Department"), whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Aubry currently holds a non-resident individual insurance producer license with the Department, pursuant to Chapter 375, RSMo;

WHEREAS, the Consumer Affairs Division has received information that Aubry acted as an insurance producer by selling, soliciting and negotiating an insurance policy to a Missouri resident without the proper license which is a violation of Sections 375.014.1, RSMo (Supp. 2013), and subjects Aubry to enforcement action by the Director;

WHEREAS, Aubry has been informed of his right to counsel and of his right to contest any attempt by the Department to discipline his insurance producer license, and states that he understands his rights to contest any such actions;


AND WHEREAS, Aubry, acknowledges and admits for purposes of this Agreement and for purposes of any future action by the Director or the Consumer Affairs Division based on any additional violation of the insurance laws or regulations by Aubry, in which action the Director or the Consumer Affairs Division alleges that the violations described herein form part of a course of conduct, a business practice, or other such series of similar violations, or that future violations by Aubry are committed knowingly, intentionally or in conscious disregard of the law, when he sold, solicited and negotiated an insurance policy to a Missouri resident prior to having a the proper license and that such conduct violated Sections 375.014.1, RSMo (Supp. 2013);

NOW, THEREFORE, in lieu of any recommendation or initiation by the Consumer Affairs Division of any action based on the violation cited in this Agreement, and after being afforded the opportunity to consult legal counsel, Aubry does hereby voluntarily and knowingly surrender and forfeit the sum of two hundred fifty dollars (\$250.00), such sum to be paid into the State School Moneys Fund pursuant to Sections 374.046 and 374.280, RSMo.


Aubry shall submit this sum to the Department by cashier's check or money order made payable to the State School Moneys Fund no later than June 26, 2015.

The parties agree that, should the Director or the Division in the future allege an additional violation of the insurance laws or regulations by Aubry, nothing in this Agreement shall preclude the Director or the Consumer Affairs Division from introducing Aubry's admissions contained in this Agreement as evidence that the acts described herein form part of a course of conduct, a business practice, or other such series of similar violations, or for purposes of showing that such later alleged acts are committed knowingly, intentionally or in conscious disregard of the law.


