VOLUNTARY FORFEITURE AGREEMENT

It is hereby agreed by BJ Hunter and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, "Director" of the "Department"), whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of bail bonds;

WHEREAS, the Consumer Affairs Division of the Department is charged with investigating bail bond agents engaged in the bail bond business pursuant to Sections 374.085, 374.190 and 374.764 RSMo and is authorized by the Director to recommend enforcement action under the laws relating to bail bonds;

WHEREAS, BJ Hunter is licensed as a Bail Bond Agent and subject to Chapter 374, RSMo;

WHEREAS, the Consumer Affairs Division has received information concerning BJ Hunter's violation of:

- **CSR 100-4.100 (2) (A), which requires a response within 20 days of an inquiry by the Consumer Affairs Division;**

and subjects BJ Hunter to enforcement action by the Director;

WHEREAS, BJ Hunter has been informed of his right to counsel and of his right to contest any attempt by the Department to discipline his bail bond license, and states that he understands his rights to contest any such actions;


AND WHEREAS, BJ Hunter, acknowledges and admits for purposes of this Agreement and for purposes of any future action by the Director or the Consumer Affairs Division based on any additional violation of the bail bond laws or regulations by BJ Hunter, in which action the Director or the Consumer Affairs Division alleges that the violation described herein forms part of a course of conduct, a business practice, or other such series of similar violations, or that future violations by BJ Hunter are committed knowingly, intentionally or in conscious disregard of the law, that he failed to provide a written response to the Consumer Affairs Division on three (3) occasions, and that such conduct violated 20 CSR 100-4.100.Mo.

NOW, THEREFORE, in lieu of any recommendation or initiation by the Consumer Affairs Division of any action based on the violations cited in this Agreement, and after being afforded the opportunity to consult legal counsel, BJ Hunter does hereby voluntarily and knowingly surrender and forfeit the sum of four hundred fifty dollars (\$450.00), such sum to be paid into the State School Moneys Fund pursuant to Sections 374.046 and 374.280, RSMo.


BJ Hunter shall submit this sum to the Department by cashier's check or money order made payable to the State School Moneys Fund no later than June 1, 2015.

The parties agree that, should the Director or the Division in the future allege an additional violation of the insurance laws or regulations by BJ Hunter, nothing in this Agreement shall preclude the Director or the Consumer Affairs Division from introducing BJ Hunter's admissions contained in this Agreement as evidence that the acts described herein form part of a course of conduct, a business practice, or other such series of similar violations, or for purposes of showing that such later alleged acts are committed knowingly, intentionally or in conscious disregard of the law.
