VOLUNTARY FORFEITURE

It is hereby agreed by Charles Touche and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri, (hereinafter, Director) whose duties, pursuant to Chapters 374, 375, and 384 RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Charles Touche holds a license as a nonresident producer and surplus lines producer with the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 374, 375 and 384 RSMo;


WHEREAS, information has been received by the Consumer Affairs Division that Charles Touche failed to file his Surplus Lines Appendix 3 tax report before March 2, 2013, and Charles Touche failed to respond within fifteen days after being given notification of his lack of filing, which is a violation pursuant to Sections 384.057 and 374.215.1, RSMo (Supp. 2012) and grounds for discipline under Sections 375.141.1(2) and 384.065(4), RSMo (Supp. 2012), subjecting Charles Touche to enforcement action by the Director;

WHEREAS, Charles Touche has been informed of the nature of the violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his licenses, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke the surplus lines license and producer license of Charles Touche, or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Charles Touche does hereby voluntarily and knowingly surrender and forfeit the sum of \$1,000, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.


