VOLUNTARY FORFEITURE AGREEMENT

It is hereby agreed by Jeffrey Wehking and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, "Director" of the "Department"), whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Jeffrey Wehking ("Wehking") has applied to receive a resident individual insurance producer license with the Department, pursuant to Chapter 375, RSMo;

WHEREAS, the Consumer Affairs Division received information concerning Wehking's failure to disclose a 2006 administrative action and failure to disclose delinquent tax obligations on his resident license application, which are violations of Sections 374.210.1(1), RSMo (Non Cum. Supp. 2014), and is grounds for discipline under Section 375.141.1(1), (2), (3), and (14), RSMo (Supp. 2013) and subjects Wehking to enforcement action by the Director;

WHEREAS, Wehking has been informed of his right to counsel and of his right to contest any attempt by the Department to refuse to issue his insurance producer license, and states that he understands his rights to contest any such actions;

AND WHEREAS, Wehking acknowledges and admits for purposes of this Agreement and for purposes of any future action by the Director or the Consumer Affairs Division based on an additional violation of the insurance laws or regulations by Wehking, in which action the Director or the Consumer Affairs Division alleges that the violations described herein form part of a course of conduct, a business practice, or other such series of similar violations, or that future violations by Wehking are committed knowingly, intentionally or in conscious disregard of the law, that he failed to disclose administrative action taken against him in 2006 and delinquent tax obligations, and that such conduct violated Section 374.210.1(1), RSMo (Non Cum. Supp. 2014);

NOW, THEREFORE, in lieu of any recommendation or initiation by the Consumer Affairs Division of any action based on the violations cited in this Agreement, and after being afforded the opportunity to consult legal counsel, Wehking does hereby voluntarily and knowingly surrender and forfeit the sum of five-hundred dollars (\$500.00), such sum to be paid


into the State School Moneys Fund pursuant to Sections 374.046 and 374.280, RSMo.

Wehking shall submit this sum to the Department by cashier's check or money order made payable to the State School Moneys Fund no later than July 18, 2016.

The parties agree that, should the Director or the Division in the future allege an additional violation of the insurance laws or regulations by Wehking, nothing in this Agreement shall preclude the Director or the Consumer Affairs Division from introducing Wehking's admissions contained in this Agreement as evidence that the acts described herein form part of a course of conduct, a business practice, or other such series of similar violations, or for purposes of showing that such later alleged acts are committed knowingly, intentionally or in conscious disregard of the law.


