VOLUNTARY FORFEITURE AGREEMENT

It is hereby agreed by Maverick National Services-Florida, LLC ("Maverick") and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, "Director" of the "Department"), whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Maverick has applied for a business entity producer insurance license with the Department, pursuant to Chapter 375, RSMo;

WHEREAS, the Consumer Affairs Division has received information concerning Maverick's failure to disclose an enforcement action in the State of Florida, which is a violation of Section 374.210.1(1), RSMo (Non Cum. Supp. 2014), and subjects Maverick to enforcement action by the Director;

WHEREAS, Maverick has been informed of its right to counsel and of its right to contest any attempt by the Department to refuse to issue its insurance producer license, and states that it understands its rights to contest any such actions;

AND WHEREAS, Maverick, acknowledges for purposes of this Agreement that it inadvertently and without malice or intent, failed to disclose an enforcement action in the State of Florida, and that as a result of such failure accepts the fine proposed by the Consumer Affairs Division as imposed by this Agreement, in violation of Section 374.210.1(1), RSMo (Non Cum. Supp. 2014).

THEREFORE, in lieu of any recommendation or initiation by the Consumer Affairs Division of any action based on the violations cited in this Agreement, and after being afforded the opportunity to consult legal counsel, Maverick does hereby voluntarily and knowingly surrender and forfeit the sum of two hundred fifty dollars (\$250.00), such sum to be paid into the State School Moneys Fund pursuant to Sections 374.046 and 374.280, RSMo.

Maverick shall submit this sum to the Department by cashier's check or money order made payable to the State School Moneys Fund no later than May 11, 2015.

The parties agree that, should the Director or the Division in the future allege an

additional violation of the insurance laws or regulations by Maverick, nothing in this Agreement shall preclude the Director or the Consumer Affairs Division from introducing Maverick's admissions contained in this Agreement as evidence that the acts described herein form part of a course of conduct, a business practice, or other such series of similar violations, or for purposes of showing that such later alleged acts are committed knowingly, intentionally or in conscious disregard of the law.
