**ORDER REFUSING TO ISSUE A MOTOR VEHICLE
EXTENDED SERVICE CONTRACT PRODUCER LICENSE**

On September 13, 2018, the Consumer Affairs Division (“Division”) submitted a Petition to the Director alleging cause for refusing to issue a motor vehicle extended service contract producer license to Cameron Aaron Reichmuth. After reviewing the Petition, the Investigative Report, and the entirety of the file, the Director issues the following findings of fact, conclusions of law, and order:

FINDINGS OF FACT

1. On April 18, 2016, the Department of Insurance, Financial Institutions and Professional Registration (“Department”) received Reichmuth’s Application for Motor Vehicle Extended Service Contract Producer License (“Application”). On his Application, Reichmuth listed his residential address as 97 Locust Ridge, Collinsville, Illinois, 62234.
2. Background Information Question Number 1 of the Application asks, in relevant part:

Have you ever been convicted of a crime, had a judgment withheld or deferred, received a suspended imposition of sentence (“SIS”) or suspended execution of sentence (“SES”), or are you currently charged with committing a crime?
3. Reichmuth answered “Yes” to Background Information Question Number 1 on his Application. Reichmuth provided court documentation regarding two criminal cases, as well as an additional written statement, regarding the following convictions:

- a. On June 21, 2010, Reichmuth pled guilty to the felony of Burglary, in violation of § 720 ILCS 5/19-1(a).¹ *State v. Cameron A. Reichmuth*, Madison County, Illinois Cir. Ct., Case No. 09-CF-2597. The court sentenced Reichmuth to four years' incarceration in the Illinois Department of Corrections, with credit for time served and a recommendation for the Impact Incarceration Program. *Id.* Reichmuth served four months in the Impact Incarceration Program boot camp, in lieu of incarceration in the Illinois Department of Corrections. *Id.*
 - b. On June 21, 2010, Reichmuth pled guilty to the felony of Unlawful Possession of Cannabis, in violation of § 720 ILCS 550/4(d). *State v. Cameron A. Reichmuth*, Madison County, Illinois Cir. Ct., Case No. 10-CF-1021. The court sentenced Reichmuth to three years' incarceration in the Illinois Department of Corrections, to run concurrently with Case No. 09-CF-2597, with credit for time served and a recommendation for the Impact Incarceration Program. *Id.* Reichmuth served four months in the Impact Incarceration Program boot camp, in lieu of incarceration in the Illinois Department of Corrections. *Id.*
4. The Division's initial investigation revealed that Reichmuth had another felony conviction that Reichmuth did not disclose in response to Background Information Question Number 1 on his Application:

On June 15, 2009, Reichmuth pled guilty to the felony of Disorderly Conduct, in violation of § 720 ILCS 5/26-1(a)(4). *State v. Cameron A. Reichmuth*, Madison County, Illinois Cir. Ct., Case No. 07-CF-896. Reichmuth was sentenced to two years' supervised probation. *Id.*

5. It is inferable, and hereby found as fact, that Reichmuth failed to disclose his 2009 Madison County, Illinois felony conviction on his Application in the hopes that the Director would look more favorably upon his Application and issue a license to him.

CONCLUSIONS OF LAW

6. Section 385.209.1 provides, in relevant part:

The director may suspend, revoke, refuse to issue, or refuse to renew a registration or license under sections 385.200 to 385.220 for any of the following causes, if the applicant or licensee or the applicant's or licensee's subsidiaries or affiliated entities acting on behalf of the

applicant or licensee in connection with the applicant's or licensee's motor vehicle extended service contract program has:

(3) Obtained or attempted to obtain a license through material misrepresentation or fraud; [or]

* * *

(5) Been convicted of any felony[.]

7. The Director may refuse to issue a motor vehicle extended service contract producer license to Reichmuth under § 385.209.1(3) because Reichmuth attempted to obtain a license through material misrepresentation or fraud because while he disclosed on his Application two felony convictions from Madison County, Illinois in 2010, *State v. Cameron A. Reichmuth*, Madison County, Illinois Cir. Ct., Case No. 09-CF-2597, and *State v. Cameron A. Reichmuth*, Madison County, Illinois Cir. Ct., Case No. 10-CF-1021, he failed to disclose a felony conviction from 2009. *State v. Cameron A. Reichmuth*, Madison County, Illinois Cir. Ct., Case No. 07-CF-896.
8. The Director may refuse to issue a motor vehicle extended service contract producer license to Reichmuth under § 385.209.1(5) because Reichmuth has been convicted of a felony. More particularly, Reichmuth has been convicted of three felonies, including Disorderly Conduct, Burglary, and Unlawful Possession of Cannabis. *State v. Cameron A. Reichmuth*, Madison County, Illinois Cir. Ct., Case No. 07-CF-896; *State v. Cameron A. Reichmuth*, Madison County, Illinois Cir. Ct., Case No. 09-CF-2597; *State v. Cameron A. Reichmuth*, Madison County, Illinois Cir. Ct., Case No. 10-CF-1021.
9. Each felony conviction constitutes a separate and sufficient ground for the Director to refuse to issue Reichmuth a motor vehicle extended service contract producer license under § 385.209.1(5).
10. The above-described instances are grounds upon which the Director may refuse to issue Reichmuth a motor vehicle extended service contract producer license. Reichmuth has three felony convictions and failed to disclose a 2009 felony conviction in response to Background Information Question Number 1 on the Application.
11. The Director has considered Reichmuth's history and all of the circumstances surrounding Reichmuth's Application. Issuing a motor vehicle extended service contract producer license to Reichmuth would not be in the interest of the public. Accordingly, the Director exercises her discretion to refuse to issue Reichmuth a motor vehicle extended service contract producer license.

12. This Order is in the public interest.

ORDER

IT IS THEREFORE ORDERED that the motor vehicle extended service contract producer license Application of **Cameron Aaron Reichmuth** is hereby **REFUSED**.
