**ORDER REFUSING TO ISSUE NON-RESIDENT MOTOR VEHICLE
EXTENDED SERVICE CONTRACT PRODUCER LICENSE**

On April 19, 2012, the Consumer Affairs Division submitted a Petition to the Director alleging cause for refusing to issue a motor vehicle extended service contract producer license to Jennifer Woodson. After reviewing the Petition, the Investigative Memo, and the entirety of the file, the Director issues the following findings of fact, conclusions of law, and order:

FINDINGS OF FACT

1. Jennifer L. Woodson, a/k/a Jennifer Veselsky, ("Woodson") is an Ohio resident with a residential address of 5016 Anson Avenue, Cleveland, Ohio 44127.
2. On or about December 8, 2004, Woodson was found guilty and sentenced to four years' incarceration for third degree felony permitting child abuse, in violation of § 2903.15 Ohio Revised Code, and third degree felony endangering children, in violation of § 2919.22 Ohio Revised Code. *State of Ohio v. Jennifer Veselsky*, Cuyahoga Co. Ct. of Common Pleas, Case No. CR-04-448644-ZA. The Court of Appeals of Ohio, Eighth District, affirmed Woodson's convictions. Opinion, October 27, 2005, No. 85729.
3. On January 3, 2012, the Department of Insurance, Financial Institutions and Professional Registration ("Department") received Woodson's Application for Motor Vehicle Extended Service Contract Producer License ("Application").

CONCLUSIONS OF LAW

4. Section 385.209 RSMo Supp. 2011, provides, in part:
 1. The director may suspend, revoke, refuse to issue, or refuse to renew a registration or license under sections 385.200 to 385.220 for any of the following causes, if the applicant or licensee or the applicant's or licensee's subsidiaries or

affiliated entities acting on behalf of the applicant or licensee in connection with the applicant's or licensee's motor vehicle extended service contract program has:

* * *

- (5) Been convicted of any felony[.]
5. Just as the principal purpose of § 375.141, the insurance producer disciplinary statute, is not to punish licensees or applicants, but to protect the public, *Ballew v. Ainsworth*, 670 S.W.2d 94, 100 (Mo. App. E.D. 1984), the purpose of § 385.209 is not to punish applicants for a motor vehicle extended service contract producer license, but to protect the public.
 6. Woodson may be refused a MVESC producer license pursuant to § 385.209.1(5) because she has been convicted of two felonies in *State of Ohio v. Jennifer Veselsky*, Cuyahoga Co. Ct. of Common Pleas, Case No. CR-04-448644-ZA.
 7. Woodson has been convicted of two felonies. Granting Woodson a MVESC producer license would not be in the interest of the public. The Director has considered Woodson's history and all of the circumstances surrounding Woodson's Application and exercises his discretion to refuse Woodson's MVESC producer license.
 8. This Order is in the public interest.


ORDER

IT IS THEREFORE ORDERED that the motor vehicle extended service producer license application of **Jennifer Woodson** is hereby **REFUSED**.


