**ORDER OF THE DIRECTOR**

NOW, on this 19<sup>th</sup> day of January, 2017, Director, John M. Huff, after consideration and review of the Stipulation of Settlement and Voluntary Forfeiture (hereinafter "Stipulation") entered into by the Division of Insurance Market Regulation (hereinafter "Division"), Argonaut Great Central Insurance Company (NAIC #19860) (hereinafter "Argonaut Great"), and Argonaut Midwest Insurance Company (NAIC #19828) (hereinafter "Argonaut Midwest"), relating to the market conduct examinations set out in the caption above, does hereby issue the following orders:

This order, issued pursuant to §374.205.2(5) RSMo 2000, §374.280 RSMo (Cum. Supp. 2013) and §374.046.15. RSMo (Cum. Supp. 2013), is in the public interest.

**IT IS THEREFORE ORDERED** that Argonaut Great, Argonaut Midwest, and the Division of Insurance Market Regulation having agreed to the Stipulation, the Director does hereby approve and agree to the Stipulation.

**IT IS FURTHER ORDERED** that Argonaut Great and Argonaut Midwest shall not engage in any of the violations of law and regulations set forth in the Stipulation, shall implement procedures to place Argonaut Great and Argonaut Midwest in full compliance with the requirements in the Stipulation, to maintain those corrective actions at all times, and shall fully comply with all terms of the Stipulation.

**IT IS FURTHER ORDERED** that Argonaut Great shall pay, and the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri, shall accept, the Voluntary Forfeiture of \$1,000 payable to the Missouri State School Fund.

**IT IS FURTHER ORDERED** that Argonaut Midwest shall pay, and the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri, shall accept, the Voluntary Forfeiture of \$1,000 payable to the Missouri State School Fund.

**IT IS SO ORDERED.**

**STIPULATION OF SETTLEMENT AND VOLUNTARY FORFEITURE**

It is hereby stipulated and agreed by the Division of Insurance Market Regulation (hereinafter, the “Division”), Argonaut Great Central Insurance Company (NAIC #19860) (hereinafter “Argonaut Great”), and Argonaut Midwest Insurance Company (NAIC #19828) (hereinafter “Argonaut Midwest”), as follows:

**WHEREAS**, the Division is a unit of the Missouri Department of Insurance, Financial Institutions and Professional Registration (hereinafter, the “Department”), an agency of the State of Missouri, created and established for administering and enforcing all laws in relation to insurance companies doing business in the State in Missouri; and

**WHEREAS**, Argonaut Great and Argonaut Midwest have been granted certificates of authority to transact the business of insurance in the State of Missouri; and

**WHEREAS**, the Division called a Market Conduct Examination of Argonaut Great and a Market Conduct Examination of Argonaut Midwest based upon findings contained in a Market Conduct Investigation; and

**WHEREAS**, the Market Conduct Investigations revealed that:

1. Argonaut Great failed to include a payment for sales tax in one commercial automobile policy first party total loss settlement even though the company’s policy provided for

payment of the sales tax in violation of §§ 375.445,<sup>1</sup> 375.936(13), 375.1007(1), and 375.1007(4), RSMo, and 20 CSR 100-1.020(1)(A).

2. Argonaut Midwest failed to include a payment for sales tax in one commercial automobile policy first party total loss settlement even though the company's policy provided for payment of the sales tax in violation of §§ 375.445, 375.936(13), 375.1007(1), and 375.1007(4), RSMo, and 20 CSR 100-1.020(1)(A).

**WHEREAS**, the Division, Argonaut Great, and Argonaut Midwest have agreed to resolve the issues raised in the Market Conduct Examinations and Market Conduct Investigations as follows:

A. **Scope of Agreement.** This Stipulation of Settlement and Voluntary Forfeiture (hereinafter, "Stipulation") embodies the entire agreement and understanding of the signatories with respect to the subject matter contained herein. The signatories hereby declare and represent that no promise, inducement or agreement not herein expressed has been made, and acknowledge that the terms and conditions of this agreement are contractual and not a mere recital.

B. **Remedial Action.** Argonaut Great and Argonaut Midwest agree to take remedial action bringing each into compliance with the statutes and regulations of Missouri and agree to maintain those remedial actions at all times. Such remedial actions shall include, but are not limited to, the following:

1. Argonaut Great and Argonaut Midwest agree that they will pay all first party automobile total loss claims, including payment for all sales taxes relating to such claims, according to the terms of their policy provisions and agree to maintain this remedial action at all times.

2. Argonaut Great agrees that it will review all first party automobile total loss claims

paid or processed at any time from April 1, 2011 to April 1, 2016 to determine if Argonaut Great paid all applicable sales taxes to total loss claimants for their damaged vehicles using the contractual value payable under the terms of each policy at the time of loss.<sup>2</sup> If all applicable sales taxes were not paid by Argonaut Great to a claimant, Argonaut Great shall pay restitution to the claimant in the amount of the sales tax payable under its policy on the date of loss, including all state, city, county and other taxes. Such restitution shall be paid with no reduction in the amount payable to the claimant if the owner of the total loss vehicle retains the vehicle as salvage, unless there is a clear and specific provision in the policy supporting the reduction. For purposes of this Stipulation, providing a claimant with a sales tax affidavit pursuant to the provisions of §144.027 does not constitute payment of all applicable sales taxes to the claimant.

3. Argonaut Midwest agrees that it will review all first party automobile total loss claims paid or processed at any time from December 20, 2011 to the date of the entry of the Final Order closing the Market Conduct Examination to determine if Argonaut Midwest paid all applicable sales taxes to total loss claimants for their damaged vehicles using the contractual value payable under the terms of each policy at the time of loss.<sup>3</sup> If all applicable sales taxes were not paid by Argonaut Midwest to a claimant, Argonaut Midwest shall pay restitution to the claimant in the amount of the sales tax payable under its policy on the date of loss, including all state, city, county and other taxes. Such restitution shall be paid with no reduction in the amount payable to the claimant if the owner of the total loss vehicle retains the vehicle as salvage, unless there is a clear and specific provision in the policy supporting the reduction. For purposes of this Stipulation, providing a claimant with a

sales tax affidavit pursuant to the provisions of §144.027 does not constitute payment of all applicable sales taxes to the claimant.

**C. Compliance.** Argonaut Great and Argonaut Midwest agree to file documentation with the Division, in a format acceptable to the Division, within 90 days of the entry of a final order of any remedial action taken to implement compliance with the terms of this Stipulation and to document payment of restitution required under the terms of this Stipulation.

**D. Examination Fees.** Argonaut Great and Argonaut Midwest agree to pay any reasonable examination fees expended by the Division in conducting its review of the documentation provided by the Company pursuant to Paragraph C of this Stipulation.

**E. Voluntary Forfeiture.** Argonaut Great agrees, voluntarily and knowingly, to surrender and forfeit the sum of \$1,000 such sum payable to the Missouri State School Fund, in accordance with §374.280. Argonaut Midwest agrees, voluntarily and knowingly, to surrender and forfeit the sum of \$1,000 such sum payable to the Missouri State School Fund, in accordance with §374.280.

**F. Other Penalties.** The Division agrees that it will not seek penalties against Argonaut Great and Argonaut Midwest, other than those agreed to in this Stipulation, in connection with Market Conduct Examinations #1610-45-TGT and #1610-46-TGT.

**G. Waivers.** Argonaut Great and Argonaut Midwest, after being advised by legal counsel, do hereby voluntarily and knowingly waive any and all rights for procedural requirements, including notice and an opportunity for a hearing, and review or appeal by any trial or appellate court, which may have otherwise applied to the Market Conduct Examinations #1610-45-TGT and #1610-46-TGT.

**H. Changes.** No changes to this Stipulation shall be effective unless made in writing

and agreed to by representatives of the Division, Argonaut Great, and Argonaut Midwest.

I. **Governing Law.** This Stipulation shall be governed and construed in accordance with the laws of the State of Missouri.

J. **Authority.** The signatories below represent, acknowledge and warrant that they are authorized to sign this Stipulation, on behalf of the Division, Argonaut Great, and Argonaut Midwest respectively.

K. **Effect of Stipulation.** This Stipulation shall not become effective until entry of a Final Order by the Director of the Department (hereinafter the "Director") approving this Stipulation.

L. **Request for an Order.** The signatories below request that the Director issue an Order approving this Stipulation and ordering the relief agreed to in the Stipulation, and consent to the issuance of such Order.


