**FINDINGS OF FACT, CONCLUSIONS OF LAW
AND ORDER OF DISCIPLINE**

John M. Huff, Director of the Missouri Department of Insurance, Financial Institutions and Professional Registration hereby makes the following findings of fact, conclusions of law and order:

FINDINGS OF FACT

1. John M. Huff is the Director of the Missouri Department of Insurance, Financial Institutions and Professional Registration (hereinafter, "Director" of the "Department") whose duties, pursuant to Chapters 374 and 375 RSMo (Supp. 2010)¹ include the supervision and regulation of Missouri insurance producers.

2. The Missouri Department of Insurance, Financial Institutions and Professional Registration ("Department") issued Warren Moellering an insurance producer license (No. 389027) on February 26, 2007. Moellering's insurance producer license was suspended for tax compliance issues on September 5, 2007, and expired on February

26, 2009. Respondent has not applied to renew the license since it expired.

3. On November 17, 2010, the Director filed a First Amended Complaint with the Administrative Hearing Commission, seeking a finding that sufficient cause existed for disciplining Moellering's insurance producer license pursuant to §§374.210.2 and 375.141.1(2) RSMo (Supp. 2009).

4. The Administrative Hearing Commission held a hearing on the First Amended Complaint on November 23, 2010, but Moellering did not appear personally or through counsel.

5. The Administrative Hearing Commission issued its Decision on March 15, 2011 finding cause to discipline Moellering's license pursuant to §375.141.1(2).

6. The Administrative Hearing Commission certified its record of the proceeding pursuant to §621.110.

7. Moellering was mailed a notice of the disciplinary hearing to be held at 9:30 a.m. on May 10, 2011, in the Department's office, 301 West High Street, Room 530, Jefferson City, Missouri. The notice was sent by U.S. Mail to Moellering's last known address with sufficient postage attached. The notice was not returned as undeliverable.

8. Moellering did not appear at the disciplinary hearing. At the hearing, counsel presented the Decision and record of the Administrative Hearing Commission and, based on the recommendation of the Investigations Section to revoke, recommended to the Hearing Officer that Moellering's Missouri insurance producer license be revoked.

9. The Director hereby adopts and incorporates the March 15, 2011, "Decision" of the Administrative Hearing Commission referenced herein and does hereby find in accordance with the same.

CONCLUSIONS OF LAW

10. Pursuant to §375.141 and §621.110 RSMo (2000), the Director has the discretion to discipline Moellering's insurance producer license, including revocation of such license.

11. Based on the nature and severity of the Mollering's conduct, sufficient grounds exist to revoke Moellering's insurance producer license pursuant to §375.141.1(2).

ORDER OF DISCIPLINE

Based on the evidence presented and the recommendation to revoke, the insurance producer license of Warren Moellering (No. 389027) is hereby REVOKED.
