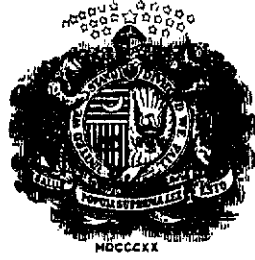

VOLUNTARY FORFEITURE

It is hereby agreed by JERRY WIGLESWORTH & CROP INSURANCE SERVICES, INC and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to insurance.

WHEREAS, JERRY WIGLESWORTH is not licensed as a Missouri insurance producer

and CROP INSURANCE SERVICES INC is licensed as a Missouri insurance business entity producer by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 375, RSMo;

WHEREAS, the investigation by the Consumer Affairs Division revealed JERRY WIGLESWORTH & CROP INSURANCE SERVICES, INC violated our insurance laws and is subject to enforcement action by the Director for the following:

1. Violation of 20 CSR 700-1.020 and Section 375.015.2 RSMo (Cum. Supp. 2008), by failing to obtain a producer and business entity producer license before transacting insurance business in the State of Missouri during the calendar years 1997, 1998, 1999, 2000, 2001, and 2002, which is grounds for discipline under Sections 375.141.1(2) and 375.145.1 RSMo (Cum. Supp. 2008);
2. Violation of 20 CSR 700-1.020 and Section 375.141.1(12) RSMo (Cum. Supp. 2008), knowingly acted as a producer and business entity producer when not licensed in the State of Missouri, which is grounds for discipline under Sections 375.141.1(2) and 375.145.1 RSMo (Cum. Supp. 2008).


WHEREAS, JERRY WIGLESWORTH & CROP INSURANCE SERVICES, INC has been informed of the nature of his violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the insurance producer license of JERRY WIGLESWORTH & CROP INSURANCE SERVICES, INC or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, JERRY WIGLESWORTH & CROP INSURANCE SERVICES, INC, does hereby voluntarily and knowingly surrender and forfeit the

sum of \$2,000.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

JERRY WIGLESWORTH & CROP INSURANCE SERVICES, INC shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than June 18, 2009.


