VOLUNTARY FORFEITURE

It is hereby agreed by Kevin Young and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the bail bond business;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond agents and general bail agents in the bail bond business pursuant to Chapter 374.085, RSMo 2000 and is authorized by the director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Kevin Young is licensed as a general bail bond agent by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 374, RSMo;


WHEREAS, information has been received by the Consumer Affairs Division concerning Kevin Young's violation, which constitutes grounds for discipline under Section 374.755.1(5) RSMo (Supp. 2010) and subjects him to enforcement action by the Director for the following: Misconduct or misrepresentation in the performance of the functions or the duties of the profession licensed or regulated by Sections 374.695 to 374.775.1 by not clearly communicating the name of the properly licensed general bail bond agent;

Whereas, Kevin Young has been informed of the nature of his violation, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his general bail bond license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;


NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the general bail bond license of Kevin Young or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Kevin Young, does hereby voluntarily and knowingly surrender and forfeit the sum of \$250.00 such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Kevin Young shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than June 30, 2011.
