
**ORDER OF THE DIRECTOR REGARDING
CHANGES TO THE VALUATION MANUAL**

After consideration and review of the changes to the valuation manual adopted by the National Association of Insurance Commissioners ("NAIC") on September 10, 2018, and direct premiums written as reported in 2017 annual statements, I, Chlora Lindley-Myers, Director of the Department of Insurance, Financial Institutions and Professional Registration, have determined: 1) that the September 10, 2018 changes to the valuation manual were adopted by the NAIC by an affirmative vote representing at least three-fourth of the members of the NAIC voting, and not less than a majority of the total membership; that the September 10, 2018 changes to the valuation manual were adopted by the NAIC by an affirmative vote representing members of the NAIC representing jurisdictions totaling greater than 75 percent of the direct premiums written as reported in the following annual statements submitted for 2017: life, accident, and health annual statements; health annual statements; or fraternal annual statements; and 2) that the condition precedent of section 376.380.6(3)(a), RSMo (Supp. 2015) has occurred.

IT IS THEREFORE ORDERED that the changes to the valuation manual adopted by the NAIC on September 10, 2018 shall become effective pursuant to section 376.380.6(3)(b), RSMo (2016), with an operative date of January 1, 2019 pursuant to section 376.380.6(3), RSMo (2016).

IT IS SO ORDERED.
