NOTICE TO INTERESTED PERSONS AND ORDER

On September 19, 2016, an Amended Notice of Hearing was issued for the Form A Statement filed by Missouri Professionals Mutual – Physicians Professional Indemnity Association proposing to acquire control of or merger with Galen Insurance Company, setting the matter for public hearing, pursuant to § 362.060 RSMo (Supp. 2015), at 9:00 a.m. on October 11, 2016, in Room 520B, Harry S Truman State Office Building, 301 West High Street, Jefferson City, Missouri. 4. Offer written argument.

Any person who has previously filed an entry of appearance and/or written notification of intent to participate in the hearing shall not refile such submissions unless the person desires to make changes to their filing(s).
