**NOTICE OF CLOSING OF SALE OF CAMERON NATIONAL INSURANCE COMPANY AND NOTICE OF AUTOMATIC TERMINATION OF THE REHABILITATION OF CAMERON NATIONAL INSURANCE COMPANY**

COMES NOW Kirsten A. Byrd, in her capacity as the court-appointed Special Deputy Liquidator of Cameron Mutual Insurance Company (“Cameron Mutual”) and provides the following notice. On September 12, 2024, the Liquidator submitted a Motion to Approve Sale of Cameron National Insurance Company (“Cameron National”), a company in rehabilitation pursuant to the Court’s Order of Rehabilitation entered August 7, 2023. On September 26, 2024, the Court entered an order approving of the sale (“Approval Order”) and directed the Liquidator to file within five business days following the closing of the sale a notice of closing and automatic termination of the rehabilitation of Cameron National. Approval Order, p. 10. **THEREFORE, NOTICE IS HEREBY GIVEN** that the sale of Cameron National closed on January 7, 2025. Accordingly, pursuant the Approval Order, effective January 7, 2025: (1) the rehabilitation of Cameron National ended and (2) the Rehabilitator has been discharged and released for all responsibilities in relation to Cameron National under the Order of Rehabilitation.
