### FINDINGS OF FACT, CONCLUSION OF LAW AND ORDER

DOUGLAS M. OMMEN, Director of the Missouri Department of Insurance, Financial Institutions, and Professional Registration, hereby makes the following Findings of Fact, Conclusion of Law, and Order.

#### **Findings of Fact**

- 1. Douglas M. Ommen is the duly appointed Director of the Missouri Department of Insurance, Financial Institutions, and Frofessional Registration (hereinafter, "Director") whose duties, pursuant to Chapters 374 and 375, RSMo, include supervision, regulation and discipline of insurance producers.
- 2. The Director issued an insurance producer license to James N. Holland, Jr. ("Holland"). Holland's producer license expired on June 25, 2006, and such license was not renewed.

- 3. The Director, through counsel, filed his Complaint with the Administrative Hearing Commission on March 6, 2006, seeking cause to discipline Holland's producer license pursuant to section 375.141.1(2) and (8), RSMo.
- 4. On August 21, 2007, and September 20, 2006, the Administrative Hearing Commission held a hearing where the Director was present, through counsel, and Holland appeared *pro se*.
- 5. On October 25, 2007, the Administrative Hearing Commission issued a Decision whereby it stated that cause exists to discipline Holland's producer license pursuant to section 375.141.1(2) and (8), RSMo.
- 6. On January 8, 2008, the Director sent Holland a Notice of Hearing via certified mail to the address on file with the Department to advise him of the Department disciplinary hearing scheduled for January 31, 2008, at 1 p.n. in Jefferson City, Missouri.
- 7. United States Postal Service electronic records indicate that notice of the certified mail was left at Holland's address on January 12, 2008. Holland failed to claim the certified mail by January 28, 2008, and such certified mail was returned to the Department. Department counsel attempted to contact Holland via telephone to advise him of the hearing, however, such attempts were unsuccessful because the telephone numbers provided by Holland were no longer in service.
  - 8. On January 31, 2008, Ho land failed to appear at the Department disciplinary hearing.
- 9. The Department hereby adopts and incorporates the Administrative Hearing Commission's Order dated October 25, 2007, referenced herein and does hereby find in accordance with the same.

#### Conclusion of Law

10. Pursuant to sections 375,141 and 621.110, RSMo, the Director has the discretion to discipline Holland's insurance producer license, including revocation of such license.

#### **ORDER**

Based on the Administrative Hearing Commission record and the Department of Insurance, Financial Institutions, and Professional Flegistration record, the insurance producer license of **James**N. Holland, Jr. is hereby REVOKED.
