**CONSENT ORDER**

DOUGLAS M. OMMEN, Director of the Department of Insurance, Financial Institutions and Professional Registration takes up the above matter for consideration and disposition. The Division of Consumer Affairs, through counsel, Mary S. Erickson, and Respondent Virgil Lee Jackson ("Respondent"), acting *pro se*, have reached a settlement in this matter and Respondent has consented to the issuance of this Consent Order.

**Findings of Fact**

1. Douglas M. Ommen is the duly appointed Director of the Missouri Department of Insurance, Financial Institutions and Professional Registration ("Director") whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision, regulation and discipline of bail bond agents and general bail bond agents.

2. The Missouri Department of Insurance, Financial Institutions and Professional Registration (“Department”), first issued a bail bond agent license (License No. BB303345) to Respondent Virgil Lee Jackson on July 29, 1996. Respondent’s bail bond agent license expired on July 30, 2007.

3. The terms set forth in this Consent Order are an appropriate disposition of this matter and entry of this order is in the public interest.

4. On May 23, 2006, the Director, through counsel, filed his First Amended Complaint with the Administrative Hearing Commission (AHC), seeking cause to discipline Respondent’s license pursuant to § 374.755.1(2), (3), and (6), RSMo (Supp. 2004). *Director v. Virgil Lee Jackson*, AHC Case No. 05-1829DI.

5. Since the filing of the First Amended Complaint in the AHC, on or about August 13, 2007, Respondent pled guilty to murder-for-hire to kill another bail bond agent in the United States District Court for the Eastern District of Missouri, in *United States v. Virgil Lee Jackson*, E.D.Mo., No. 4:05-CR-00605. On or about November 1, 2007, Respondent was sentenced to ten (10) years in federal prison on the guilty plea for murder-for-hire.

6. The crime of murder-for-hire in Missouri would be the crime of conspiracy to commit murder under § 564.016, and a violation of a law of Missouri. Therefore, sufficient grounds exist for the Department to seek to discipline Respondent’s bail bond agent license pursuant to § 374.755.1(6) RSMo (Supp. 2007).

7. Respondent retained counsel for the proceeding before the AHC and filed an Answer to the First Amended Complaint.

8. On or about January 8, 2008, Respondent's counsel withdrew their representation of Respondent before their AHC. Respondent acknowledges that he is no longer represented by counsel before the AHC or in any matter pending before the Director or Department.

9. Respondent desires to permanently surrender his Missouri bail bond agent license and to resolve the matter pending before the AHC. Upon execution of this agreed Consent Order by Respondent and receipt of same by the Department, the Department shall dismiss, without prejudice, its action before the AHC, *Director v. Virgil Lee Jackson*, AHC Case No. 05-1829DI.

10. Respondent stipulates and agrees to waive any rights that he may have to a hearing before the AHC, the Director or Department, and any rights to seek judicial review or other challenge or contest of the terms and conditions of this Order and forever releases and holds harmless the Department, the Director and his agents, and the Consumer Affairs Division from any and all liability and claims arising out of, pertaining to or relating to this matter.

11. Respondent further agrees and acknowledges that the Director or Department will deny any future application for a bail bond agent license, general bail bond agent license or any license submitted by Respondent to the Director or Department.

12. Entry of this Order is in the public interest.

13. Each signatory to this Consent Order certifies by signing that he or she is fully authorized, in his or her own capacity, or by the named party he or she represents, to accept the terms and provisions of this Consent Order in their entirety, and agrees, in his or her personal or representational capacity, to be bound by the terms of this Consent Order.

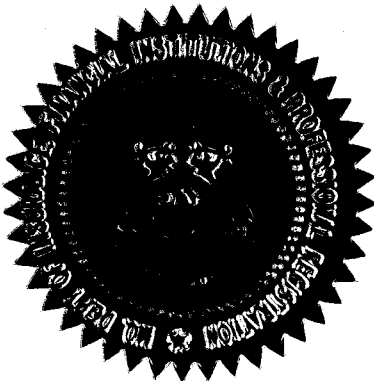
**Conclusion of Law**

14. The Consumer Affairs Division is authorized to settle this matter and the Director is authorized to issue this Consent Order in the public interest pursuant to §§ 374.046, 375.141, and 621.045 RSMo (Supp. 2007).

**ORDER**

IT IS ORDERED THAT Respondent Virgil Lee Jackson's bail bond agent license is hereby revoked.
