FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER OF DISCIPLINE

DOUGLAS M. OMMEN, Director of the Missouri Department of Insurance, Financial Institutions and Professional Registration (hereinafter, "Department"), makes the following findings of fact, conclusions of law and order.

FINDINGS OF FACT

- 1. Douglas M. Ommen is the Director of the Missouri Department of Insurance, Financial Institutions and Professional Registration (hereinafter, "Director") whose duties, pursuant to Chapter 374, RSMo, include the supervision, regulation, and discipline of bail bond agents.
- 2. Ozell Scott (hereinafter, "Scott") was issued a bail bond agent license (number BB305918) by the Director, on August 28, 2001, which license is current and active.
- 3. The Director filed a Complaint against Scott with the Administrative Hearing Commission on July 10, 2006, seeking a finding that sufficient cause existed for disciplining Scott's bail bond agent license based on information and allegations that he violated section 374.755.1(2),

RSMo Cum. Supp. 2005.

- 4. On December 13, 2006, a hearing was held on the Director's Complaint before the Administrative Hearing Commission. Scott did not appear at the hearing.
- 5. On March 22, 2007, the Administrative Hearing Commission issued its "Findings of Fact and Conclusions of Law", finding cause to discipline the bail bond agent license of Scott pursuant to § 374.755.1(2), RSMo. On April 24, 2007, the Administrative Hearing Commission certified the record of its proceeding to the Director pursuant to § 621.110, RSMo 2000.
- 6. Thereafter, the Director mailed to Scott a notice of disciplinary hearing, with said hearing to be held at 10:00 a.m. on June 18, 2007, in the offices of the Director, 301 West High Street, Room 530, Jefferson City, Missouri.
- 7. The disciplinary hearing was held on June 18, 2007, in the offices of the Director. Scott did not appear. At the hearing, counsel for the Division of Consumer Affairs presented the decision, record and order of the Administrative Hearing Commission and recommended to the Director that Scott's bail bond agent license be revoked.
- 8. The Department hereby adopts and incorporates the March 22, 2007, "Findings of Fact and Conclusions of Law" of the Administrative Hearing Commission referenced herein and does hereby find in accordance with the same.

CONCLUSIONS OF LAW

9. Pursuant to § 374.755, RSMo Cum. Supp. 2005 and § 621.110, RSMo 2000, the Director has the discretion to discipline Scott's bail bond agent license, including revocation of such license.

ORDER OF REVOCATION

Based on the evidence presented and the aforementioned recommendation to revoke, the bail bond agent license of Scott is hereby revoked.
