**FINDINGS OF FACT, CONCLUSIONS OF LAW
AND ORDER OF DISCIPLINE**

DOUGLAS M. OMMEN, Director of the Missouri Department of Insurance, Financial Institutions, and Professional Registration, hereby makes the following Findings of Fact, Conclusions of Law, and Order.

Findings of Fact

1. Douglas M. Ommen is the duly appointed Director of the Missouri Department of Insurance, Financial Institutions, and Professional Registration (hereinafter, "Director") whose duties, pursuant to Chapter 375, RSMo, include supervision, regulation and discipline of insurance producers.

2. Richard M. Nixon (hereinafter, "Nixon") was issued an insurance producer license by the Director, number PR177489. Nixon surrendered his producer license, via letter, to the Director

on April 5, 2006. Nixon's producer license expired on June 3, 2006.

3. The Director filed his Complaint with the Administrative Hearing Commission on August 28, 2006, seeking cause to discipline Nixon's insurance producer license, based upon sections 375.141.1(4), 375.141.1(5), and 375.141.1(6), RSMo (2000) and sections 375.141.1(4), 375.141.1(6), 375.141.1(8), and 375.141.1(10), RSMo (Cum. Supp. 2005).

4. On November 20, 2006, the Director and Nixon filed a Stipulation of Facts and Consent to Finding Cause for Discipline and Waiver of Hearing with the Administrative Hearing Commission.

5. On November 28, 2006, the Administrative Hearing Commission issued its Consent Order, incorporating the facts from the Stipulation of Facts and Consent to Finding of Cause for Discipline and Waiver of Hearing, concluding that Nixon's insurance producer license is subject to discipline pursuant to § 375.141.1(6), RSMo (2000) and certified the record of its proceeding to the Director pursuant to § 621.110, RSMo (2000).

6. On January 9, 2007, Nixon waived his right to a departmental disciplinary hearing.

7. The Department hereby adopts and incorporates the Administrative Hearing Commission's "Consent Order" dated November 28, 2006 referenced herein and does hereby find in accordance with the same.

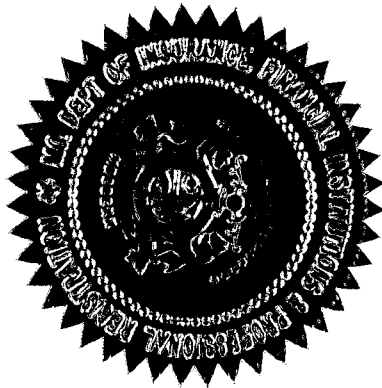
Conclusions of Law

8. Pursuant to sections 375.141 and 621.110, RSMo, the Director has the discretion to discipline the insurance producer license of Nixon, including revocation of such license.

ORDER

Based on the Administrative Hearing Commission record, the Department of Insurance, Financial Institutions, and Professional Registration record and the Stipulation between the parties, the insurance producer license of Richard M. Nixon is hereby REVOKED.
