### VOLUNTARY FORFEITURE

It is hereby agreed by Amy Helen Plummer Producer Number 0149263 (Plummer) and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374, 375 and 381 RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Plummer was previously licensed as an insurance producer by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 374, 375 and 381, RSMo, cancelled the license in 2008 and has an application currently pending for another license;


WHEREAS, the investigation has revealed that Plummer engaged in the business of title insurance without a license between April 20, 2009 and January 15, 2010 and between April 2, 2012 and May 6, 2013 in violation of Sections 381.115.1 and 381.115.2 (2), RSMo (Supp 2012), a ground for refusal to issue an insurance license pursuant to Section 375.141.1 (2), RSMo (Supp 2012) subjecting Plummer to enforcement action by the Director;

WHEREAS, Plummer has been informed of the nature of her violation, of her right to counsel and of her right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration to discipline her producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that she understands her rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to refuse the pending application for an insurance producer license or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Plummer does hereby voluntarily and knowingly surrender and forfeit the sum of one thousand five hundred dollars (\$1,500.00) such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Plummer shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration by cashier's check or money order made payable to the Missouri State School Fund no later than **June 10, 2013**.
