VOLUNTARY FORFEITURE

It is hereby agreed by Danny Brown and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond agents and general bail agents in the bail bond business pursuant to Chapter 374.085, RSMo 2000 and is authorized by the director to recommend enforcement action under the laws relating to insurance.

WHEREAS, Danny Brown is licensed as a bail bond agent by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 374, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division concerning Danny Brown's violation of **Section 374.716.1 RSMo (Cum. Supp. 2008)** – by failing to account for each power of attorney assigned by the general agent on a weekly basis and remit all sums collected and owed to the general bail bond agent; and **Section 374.755.1 (6) RSMo (Cum. Supp. 2008)** – Violation on any provision or any obligation imposed by the laws of this state, department of insurance rules and regulations...by failing to respond to the department within the required time in 20 CSR 100-4.100 (2) (A) regarding a bail bond investigation, which subjects him *to enforcement action* by the Director;


WHEREAS, Danny Brown has been informed of the nature of his violation, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his bail bond license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the bail bond license of Danny Brown or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Danny Brown, does hereby voluntarily and knowingly surrender and forfeit the sum of \$500.00 such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.


Danny Brown shall submit this sum to the Department of Insurance, Financial
