

VOLUNTARY FORFEITURE AGREEMENT

It is hereby agreed by DailyFeats, Inc. DBA Maxwell Health and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, "Director" of the "Department"), whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, DailyFeats, Inc. DBA Maxwell Health ("Maxwell Health") has applied to renew a non-resident business entity producer license with the Department, pursuant to Chapter 375, RSMo;

WHEREAS, the Consumer Affairs Division has received information concerning Maxwell Health's failure to report a 2015 administrative action by the state of Massachusetts on the renewal application, which is a violation of Section 374.210.1(1), RSMo (Non Cum. Supp. 2014) and subjects Maxwell Health to enforcement action by the Director;

WHEREAS, Maxwell Health has been informed of its right to counsel and of its right to contest any attempt by the Department to refuse to renew its business entity producer license, and states that it understands its rights to contest any such actions;

AND WHEREAS, Maxwell Health acknowledges and admits for purposes of this Agreement and for purposes of any future action by the Director or the Consumer Affairs Division based on an additional violation of the insurance laws or regulations by Maxwell Health, in which action the Director or the Consumer Affairs Division alleges that the violation described herein forms part of a course of conduct, a business practice, or other such series of similar violations, or that future violations by Maxwell Health are committed knowingly, intentionally or in conscious disregard of the law, that it failed to report a 2015 administrative action taken by the state of Massachusetts and that such conduct violated Section 374.210.1(1) RSMo (Non Cum. Supp. 2014);

NOW, THEREFORE, in lieu of any recommendation or initiation by the Consumer Affairs Division of any action based on the violation cited in this Agreement, and after being afforded the opportunity to consult legal counsel, Maxwell Health does hereby voluntarily and knowingly surrender and forfeit the sum of two hundred fifty dollars (\$250), such sum to be paid

into the State School Moneys Fund pursuant to Sections 374.046 and 374.280, RSMo.

Maxwell Health shall submit this sum to the Department by cashier's check or money order made payable to the State School Moneys Fund no later than June 6, 2016.

The parties agree that, should the Director or the Division in the future allege an additional violation of the insurance laws or regulations by Maxwell Health, nothing in this Agreement shall preclude the Director or the Consumer Affairs Division from introducing Maxwell Health's admissions contained in this Agreement as evidence that the acts described herein form part of a course of conduct, a business practice, or other such series of similar violations, or for purposes of showing that such later alleged acts are committed knowingly, intentionally or in conscious disregard of the law.


