### VOLUNTARY FORFEITURE AGREEMENT

It is hereby agreed to by Timothy R. Vonder Haar ("Vonder Haar") and the Division of Consumer Affairs ("Division") of the Department of Commerce and Insurance, as follows:

WHEREAS, Chlora Lindley-Myers, is the duly appointed Director of the Department of Commerce and Insurance, State of Missouri (hereinafter, "Director" of the "Department"), whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Division is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo, and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Vonder Haar holds an active resident producer license with the Department, pursuant to Chapter 375, RSMo;

WHEREAS, the Division has received information that Vonder Haar signed the name(s) of insured without authorization; instructed insured to misrepresent facts on an application to insurer; misrepresented cash value illustrations on a life insurance product and policy coverage to insured; provided inaccurate payroll figures to an insurer and issued insurance ID cards for two vehicles without procuring auto coverage for the insured; which are in violations of Section 375.144, RSMo and Missouri Regulation 20 CSR 700-1.140;

Additionally, Vonder Haar materially aided an insurer to violate Section 375.144, RSMo and Missouri Regulation 20 CSR 700-1.140, when Vonder Haar submitting inaccurate payroll to an insurer and mispresenting coverage on behalf of an insurer to an insured, which is a violation of Section 375.145.1, RSMo, and subjects Vonder Haar to enforcement action by the Director;

WHEREAS, Vonder Haar has been informed of his right to counsel and of his right to contest any attempt by the Department to discipline his insurance producer license, and states that he understands his rights to contest any such actions;

AND WHEREAS, Vonder Haar acknowledges and admits for purposes of this Agreement and for purposes of any future action by the Director or the Division based on an additional violation of the insurance laws or regulations by Vonder Haar, in which action the Director or the Division alleges that the violation described herein forms part of a course of conduct, a business practice, or other such series of similar violations, or that future violations by Vonder Haar are committed knowingly, intentionally or in conscious disregard of the law, that Vonder Haar signed the name(s) of insured without authorization; instructed insured to misrepresent facts on an application to insurer; misrepresented cash value illustrations on a life insurance product and policy coverage to insured; provided inaccurate payroll figures to an insurer and issued insurance ID cards for two vehicles without procuring auto coverage for the insured; which are in violations of Section 375.144, RSMo, and Missouri Regulation 20 CSR 700-1.140;

Additionally, Vonder Haar materially aided insurer to violate Section 375.144, RSMo, and Missouri Regulation 20 CSR 700-1.140, when Von Haar submitted inaccurate payroll to an insurer and


misrepresented coverage on behalf of an insurer to an insured, which is a violation of Section 375.145.1, RSMo.

NOW, THEREFORE, in lieu of any recommendation or initiation by the Division of any action based on the violations cited in this Agreement, and after being afforded the opportunity to consult legal counsel, Vonder Haar does hereby voluntarily and knowingly surrender and forfeit the sum of five thousand one hundred dollars (\$5,100.00), such sum to be paid into the State School Moneys Fund pursuant to Sections 374.046 and 374.280, RSMo.


Vonder Haar shall submit this sum to the Department by cashier's check or money order made payable to the State School Moneys Fund no later than November 25, 2024.

The parties agree that, should the Director or the Division in the future allege an additional violation of the insurance laws or regulations by Vonder Haar, nothing in this Agreement shall preclude the Director or the Division from introducing Vonder Haar's admissions contained in this Agreement as evidence that the acts described herein form part of a course of conduct, a business practice, or other such series of similar violations, or for purposes of showing that such later alleged acts are committed knowingly, intentionally or in conscious disregard of the law.
