### VOLUNTARY FORFEITURE

It is hereby agreed by Tommy Griggsby and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri, (hereinafter, Director) whose duties, pursuant to Chapters 374, 375 and 385, RSMo, include the supervision and regulation of the business of motor vehicle extended service contracts;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of motor vehicle extended service contracts pursuant to Section 385.216, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to motor vehicle extended service contracts;

WHEREAS, Tommy Griggsby has applied for his license as a resident motor vehicle extended service contract producer with the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 385, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division that Tommy Griggsby failed to correctly answer on the license application that he owes a delinquent tax obligation to the State of Missouri, which is grounds for discipline under Section 385.209.1(3) RSMo (Supp. 2011), subjecting Tommy Griggsby to enforcement action by the Director;

WHEREAS, Tommy Griggsby has been informed of the nature of the violation, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to refuse his license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;


NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to deny the license of Tommy Griggsby, or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Tommy Griggsby does hereby voluntarily and knowingly surrender and forfeit the sum of \$250.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Tommy Griggsby shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than July 25, 2012.
