It is hereby agreed by Deborah L. Hall and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to insurance.

WHEREAS, Deborah L. Hall is licensed as an insurance producer by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 375, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division concerning Deborah L. Hall, which alleges that she enrolled Marilyn Houdek, but another producer, Maggie Oberreither, signed the application as the selling agent, which is a violation of Section 375.141.1(8)(10) RSMo (Cum. Supp. 2008) and Sections 375.144.(1)(2)(3)(4) RSMo (Cum. Supp. 2008); reimbursing Ms. Houdek \$145.00 for premiums is rebating, a violation of Section 375.936(9) RSMo (Cum. Supp. 2008); subjecting her to enforcement action by the Director;

WHEREAS, Deborah L. Hall has been informed of the nature of her violations, of her right to counsel and of her right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline her insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that she understands her rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the insurance producer license of Deborah L. Hall or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Deborah L. Hall, does hereby voluntarily and knowingly surrender and forfeit the sum of \$700.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Deborah L. Hall shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than February 3, 2010.


