It is hereby agreed by Julie Harris and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the bail bond business;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond agents and general bail bond agents in the bail bond business pursuant to Section 374.085, RSMo and Section 374.764, RSMo (Supp. 2012) and is authorized by the director to recommend enforcement action under the laws relating to bail bonds;

WHEREAS, Julie Harris is licensed as a bail bond agent;

WHEREAS, information has been received by the Consumer Affairs Division concerning Julie Harris' violations:

**Section 374.755.1(10) RSMo (Supp. 2012)** – Assisting or enabling any person to practice or offer to practice the profession ... who is not currently licensed and eligible to practice.

**Section 374.755.1(6) RSMo (Supp. 2012)** – Violation of any provision or an obligation imposed by the laws of this state, department of insurance rules and regulations, or aiding or abetting other persons to violate such laws, orders, regulations, or subpoena in violating Section 374.755.1 by failing to notify law enforcement of an apprehension.

**Section 374.755.1(5) RSMo (Supp. 2012)** - By displaying incompetency, gross negligence or misrepresentation in providing an unlicensed individual with a Surrender Form and allowing or permitting said individual to surrender a fugitive to the Mississippi County Jail.

which subjects Julie Harris to enforcement action by the Director;


WHEREAS, Julie Harris has been informed of the nature of her violations, of her right to counsel and of her right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration to discipline her bail bond license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that she understands her rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the bail bond agent license of Julie Harris or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Julie Harris, does hereby voluntarily and knowingly surrender and forfeit the sum of \$1500.00, such sum to be paid into the Missouri State School Fund pursuant

to Sections 374.046 and 374.280, RSMo.

Julie Harris shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration by cashier's check or money order made payable to the Missouri State School Fund no later than August 9, 2013.


