VOLUNTARY FORFEITURE AGREEMENT

It is hereby agreed by Jason Keith Jungeblut and the Division of Consumer Affairs of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, Chlora Lindley-Myers, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, "Director" of the "Department"), whose duties, pursuant to Chapters 374, 375 and 381, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Division of Consumer Affairs ("Division") of the Department is

charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Jason Keith Jungeblut ("Jungeblut") has an individual insurance producer license with the Department, pursuant to Chapter 375, RSMo;

WHEREAS, the Division has received information concerning Jungeblut's failure to have a valid insurance producer license with the line of authority in "Title," when he handled escrows, settlements or closings for the business of title insurance in violation of Sections 381.115.1 and 381.115.2(2), RSMo (Supp. 2013). Such conduct subjects Jungeblut to enforcement action by the Director;

WHEREAS, Jungeblut has been informed of his right to counsel and of his right to contest any attempt by the Department to refuse to issue his insurance producer license, and states that he understands his rights to contest any such actions;

AND WHEREAS, Jungeblut, acknowledges and admits for purposes of this Agreement that he failed to have a valid insurance producer license with the line of authority in "Title," when he handled escrows, settlements or closings for the business of title insurance in violation of Sections 381.115.1 and 381.115.2(2), RSMo (Supp. 2013).


NOW, THEREFORE, in lieu of any recommendation or initiation by the Division of any action based on the violations cited in this Agreement, and after being afforded the opportunity to consult legal counsel, Jungeblut does hereby voluntarily and knowingly surrender and forfeit the sum of two hundred fifty dollars (\$250.00), such sum to be paid into the State School Moneys Fund pursuant to Sections 374.046 and 374.280, RSMo.

Jungeblut shall submit this sum to the Department by cashier's check or money

order made payable to the State School Moneys Fund no later than September 15, 2017.

The parties agree that, should the Director or the Division in the future allege an additional violation of the insurance laws or regulations by Jungeblut, nothing in this Agreement shall preclude the Director or the Division from introducing Jungeblut's violations in any future allegations.


