VOLUNTARY FORFEITURE AGREEMENT

It is hereby agreed by Kansas Life Insurance Agency, Inc, ("KLIA") and the Consumer Affairs Division ("Division") of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, "Director" of the "Department"), whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Division is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, KLIA is licensed as a non-resident business entity producer by the

Department pursuant to Chapter 375, RSMo;

WHEREAS, the Division has received information concerning KLIA's misstatement on the license application regarding a FINRA administrative action, which is a violation of Section 374.210.1(1), RSMo (Non Cum. Supp. 2014), and failing to provide an adequate and timely response, which is a violation of 20 CSR 100-4.100 (2) (A). KLIA is subject to enforcement action by the Director;

WHEREAS, KLIA has been informed of its right to counsel and of its right to contest any attempt by the Department to revoke its insurance producer license, and states that it understands its rights to contest any such actions;


AND WHEREAS, KLIA acknowledges and admits for purposes of this Agreement and for purposes of any future action by the Director or the Division based on an additional violation of the insurance laws or regulations by KLIA, in which action the Director or the Division alleges that the violations described herein form part of a course of conduct, a business practice, or other such series of similar violations, that it misrepresented a license application and failed to respond timely, and that such conduct violated Section 374.210.1(1), RSMo (Non Cum. Supp. 2014) and 20 CSR 100-4.100 (2) (A).

NOW, THEREFORE, in lieu of any recommendation or imitation by the Division of any action based on the violation cited in this Agreement, and after being afforded the opportunity to consult legal counsel, KLIA does hereby voluntarily and knowingly surrender and forfeit the sum of three hundred and fifty dollars (\$350.00), such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

KLIA shall submit this sum to the Department by cashier's check or money order made payable to the Missouri State School Fund no later than January 14, 2016.

The parties agree that, should the Director or the Division in the future allege an additional violation of the insurance laws or regulations by KLIA, nothing in this Agreement shall preclude the Director or the Division from introducing admissions contained in this Agreement as evidence that the acts or omissions described herein form part of a course of conduct, a business practice, or other such series of similar violations, or for purposes of showing that such later alleged acts are committed knowingly, intentionally or in conscious disregard of the law.
