VOLUNTARY FORFEITURE

It is hereby agreed by Donald Miller and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond agents and general bail bond agents in the bail bond business pursuant to Section 374.085, RSMo (2000) and Section 374.764, RSMo (Supp. 2010) and is authorized by the director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Donald Miller is a licensed general bail bond agent;


WHEREAS, information has been received by the Consumer Affairs Division concerning Donald Miller's violation of Section 374.755.1(5) RSMo (Supp. 2010) , including Misappropriation of the premium, collateral, or other things of value given to a bail bond agent or a general bail bond agent for the taking of bail...in the performance of the functions or duties of the profession, subjecting Donald Miller to enforcement action by the Director;

WHEREAS, Donald Miller has been informed of the nature of this violation, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline the general bail bond license of Donald Miller or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;


NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the general bail bond license of Donald Miller or to impose any other penalties provided for by statute for the above-described violation, after being afforded the opportunity to consult legal counsel, Donald Miller, does hereby voluntarily and knowingly surrender and forfeit the sum of \$150.00 such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Donald Miller shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than April 29, 2011.
