VOLUNTARY FORFEITURE AGREEMENT

It is hereby agreed by ROBERT E. BLEVINS and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff, or his successor, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to insurance.

WHEREAS, ROBERT E. BLEVINS has been licensed in Missouri as a resident insurance producer since 1990 under License PR274413 by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 375, RSMo;

WHEREAS, the investigation by the Consumer Affairs Division revealed:

- ROBERT E. BLEVINS entered into personal financial transactions by borrowing money from one of his insurance clients.
- ROBERT E. BLEVINS solicited loans from the insurance client on at least seven different occasions during the period November 18, 2005 to January 28, 2008.
- 3. ROBERT E. BLEVINS later made full restitution of all loans.

The activity by ROBERT E. BLEVINS which is set out above, subjects him to

enforcement action by the Director for the following violation:

20 CSR 700-1.140(3), No insurance producer shall obtain or solicit for a loan from an insurance client or former or prospective insurance client or any type of ownership interest in any insurance policy held by an insurance client or former or prospective insurance client.

WHEREAS, ROBERT E. BLEVINS has been informed of the nature of his violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the insurance producer license of ROBERT E. BLEVINS or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, ROBERT E. BLEVINS, does hereby voluntarily and knowingly surrender and forfeit the sum of one thousand dollars (\$1,000.00), such sum to be paid to the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

ROBERT E. BLEVINS shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made **payable to Missouri State School Fund** no later than Friday, May 28, 2010.
