VOLUNTARY FORFEITURE

It is hereby agreed by Jon Donovan Tanner and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri, (hereinafter, Director) whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo 2000 and is authorized by the Director to recommend

enforcement action under the laws relating to insurance;

· WHEREAS, Jon Donovan Tanner has applied to renew his license as an insurance producer with the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 374 and 375, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division which alleges that Jon Donovan Tanner failed to report an administrative action within thirty days of the final disposition of the matter, in violation of Section 375.141.6 RSMo (Cum. Supp. 2008), subjecting Jon Donovan Tanner to enforcement action by the Director;

WHEREAS, Jon Donovan Tanner failed to file the required 2007 Surplus Lines Tax Report on or before March 2, 2008 and Jon Donovan Tanner failed to file the required 2008 Surplus Lines Tax Report on or before March 2, 2009, in violation of Section 384.057 RSMo, subjecting Jon Donovan Tanner to enforcement action by the Director;


WHEREAS, Jon Donovan Tanner has been informed of the nature of the violation, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understand his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to deny the renewal license of Jon Donovan Tanner, or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal

counsel, Jon Donovan Tanner does hereby voluntarily and knowingly surrender and forfeit the sum of \$2,250.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Jon Donovan Tanner shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than July 20, 2009.
