**ORDER OF REVOCATION**

JOHN M. HUFF, Director of the Missouri Department of Insurance, Financial Institutions, and Professional Registration, hereby issues the following Findings of Fact, Conclusions of Law, and Order of Revocation.

**Findings of Fact**

1. John M. Huff is the duly appointed Director of the Missouri Department of Insurance, Financial Institutions, and Professional Registration (hereinafter, "Director" of the "Department"). The Director has the duty to administer Chapters 374 and 375 RSMo, which includes the supervision, regulation, and discipline of insurance companies, agencies, and producers licensed to operate and conduct business in the State of Missouri.

2. The Department issued Respondent Harry Taylay ("Taylay") an insurance

producer license (No. 134181) on December 8, 1986. Taylay's license was suspended for state tax non-compliance on March 23, 2011 in accordance with §324.010 RSMo Supp. 2010. Taylay's license is set to expire on December 8, 2012.

3. On November 28, 2011, the Director filed a Complaint with the Administrative Hearing Commission ("AHC"), Case No. 11-2294 DI, against Taylay alleging that he has cause to discipline his insurance producer license pursuant to §§375.141.1(2), (8), and (14) RSMo Supp. 2010, for:

- a. Obtaining a loan from an insurance client in violation of 20 CSR 700-1.140(3); and
- b. Failing to pay \$3,636.20 income taxes to the State of Missouri from Tax Year 2006.

4. On November 28, 2011, the AHC attempted to serve the Director's Complaint on Taylay by certified mail at the address the Director had on file for Taylay, 18023 Kent Circle, Independence, Missouri 64057. The certified mail was returned to the AHC with a notation that the resident had moved and left no address.

5. On December 14, 2011, Department paralegal Kathryn Randolph, attempted to serve the Complaint on Taylay by UPS, signature required, at 18023 Kent Circle, Independence, Missouri 64057. UPS returned the package to the Department as undeliverable.

6. On December 21, 2011, Department paralegal Kathryn Randolph, contracted with HPS Process Service to attempt to serve the Complaint on Taylay at 18023 Kent Circle, Independence, Missouri 64057. HPS Process Service attempted to

serve Taylay at that address, but Taylay had moved and the address was vacant.

7. Taylay's current address is unknown.

8. Section 375.141.5 provides:

Every insurance producer licensed in this state shall notify the director of any change of address, on forms prescribed by the director, within thirty days of the change. If the failure to notify the director of the change of address results in an inability to serve the insurance producer with a complaint as provided by sections 621.045 to 621.198, RSMo, then the director may immediately revoke the license of the insurance producer until such time as service may be obtained.

#### Conclusions of Law

9. Pursuant to §375.141, the Director has the discretion to discipline Taylay's insurance license, including revocation of such license.

10. Pursuant to §375.141.5, such revocation may be immediate when an insurance producer's failure to notify the Director of any change of address within thirty (30) days of the change results in an inability to serve the insurance producer with a complaint as provided by §§621.045 to 621.198 RSMo. Such revocation may be effective until such time as service may be obtained.

11. Taylay's failure to notify the Director of a change of address within 30 days of the change has resulted in an inability to serve Taylay with an AHC Complaint as provided by §§621.045 to 621.198 RSMo.

ORDER

IT IS HEREBY ORDERED that the insurance producer license of Harry Taylay (License No. 134181) is REVOKED until such time as service of the Complaint filed with the Administrative Hearing Commission on November 28, 2011, Case No. 11-2294 DI, may be obtained or until such time as service of a complaint in a future Administrative Hearing Commission action against Harry Taylay may be obtained.
