VOLUNTARY FORFEITURE

It is hereby agreed by David Coffman and US Insurance Services, Inc. and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Acting Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 375 RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085 RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance.

WHEREAS, US Insurance Service, Inc. is licensed as an insurance producer by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 375 RSMo;

WHEREAS, information has been received by the Consumer Affairs Division concerning US

Insurance Services, Inc., which alleges that administrative actions in New Hampshire and Florida were not reported within thirty days as required by Section 375.141.6 RSMo (Cum. Supp. 2007), subjecting US Insurance Services, Inc. to enforcement action by the Director;

WHEREAS, US Insurance Services, Inc. has been informed of the nature of their violations, of their right to counsel and of their right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline their insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that they understand their rights to contest any such actions;

NOW, THEREFORE, in complete settlement of the investigation in File Number 08A000618, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the insurance producer license of US Insurance Services, Inc. or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, US Insurance Services, Inc., without any admission of a violation of the law, does hereby voluntarily and knowingly surrender and forfeit the sum of \$250.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo (Cum. Supp. 2007).

US Insurance Services, Inc. shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than March 3, 2008.


